2. The Artist agrees that the Artist's art work(s) is original to the Artist, and does not infringe upon or violate the copyright of others.
3. By signing below, the Artist specifically states the Artist's understanding and agreement that the City makes no promises or representations, express or implied, against any damage, destruction, theft or other loss of or to the art work(s) that may occur while such art work(s) is in or on the Center premises. The City shall not have any liability for, and does not give any promise or representation, express or implied, against, any such damage, destruction, theft or other loss to the art work(s) in or on the Center premises. The City is not responsible for, and does not accept any liability for, any damage, destruction, theft or other loss to the art work(s) during delivery to or removal from the Center premises by the Artist or by any other person.
4. Artist waives and releases the City of and from any and all liability for damage, destruction, theft or other loss that may occur to the art work(s) for any reason in or on the Center premises.

5. Artist agrees to indemnify, and hold harmless, the City from and against any and all claims, liability, damage or loss (including but not limited to reasonable attorneys' fees and expenses) arising out of or related to any damage, destruction, theft or other loss to all or any part of the art work(s) while in or on the premises of the Center.
6. Artist represents that Artist is the sole owner of the art work(s) to be displayed by Artist at the Center, and that representation of such sole ownership shall be true continuously while all or any part of the art work(s) is in or on the Center premises. Artist further represents that, as the sole owner, Artist has full and complete authority to execute this document, and that no other person or entity has any interest in the art work(s) that would require them to also execute this form.
7. Artist has listed on page 3 of this form an itemized description of each art work to be displayed by Artist in the Center.
8. This document is binding on the Artist's heirs, executors, administrators, successors and assigns.
