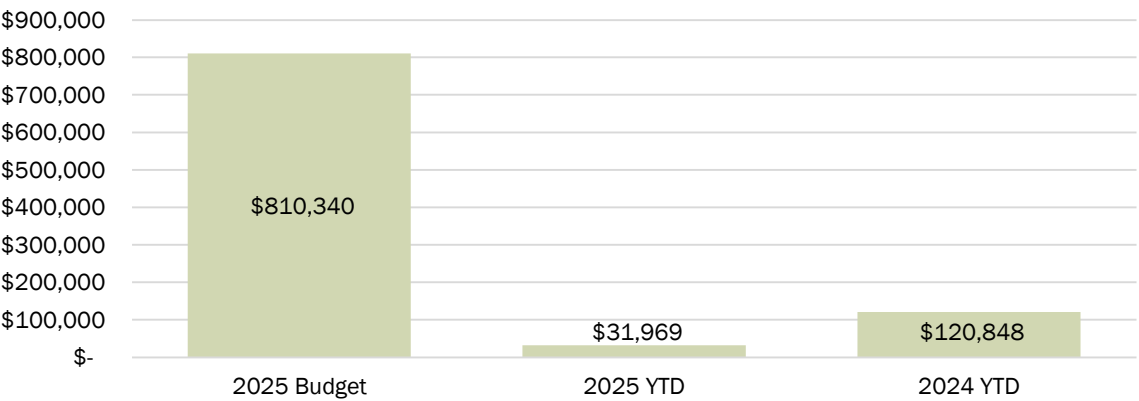

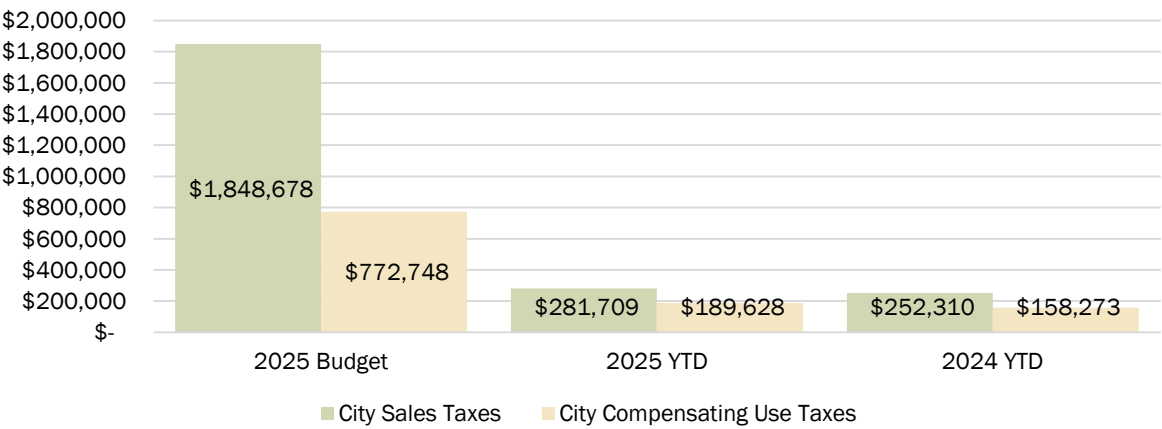

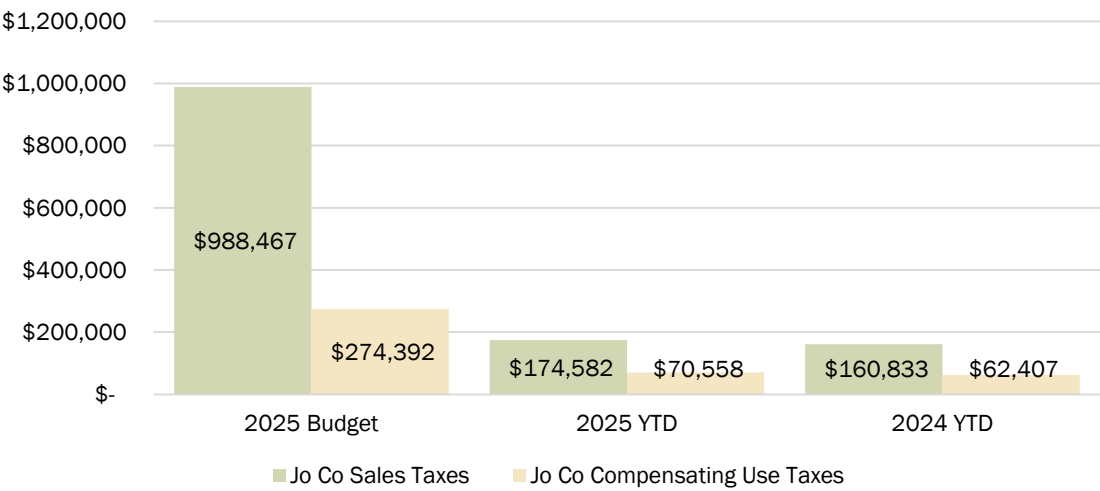

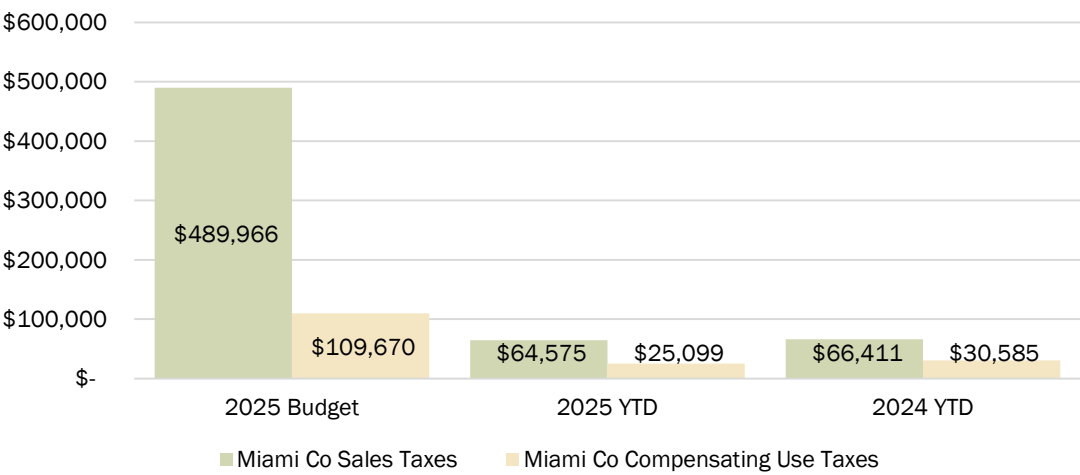
City Sales and Use Taxes

Miami County Sales & Use Taxes

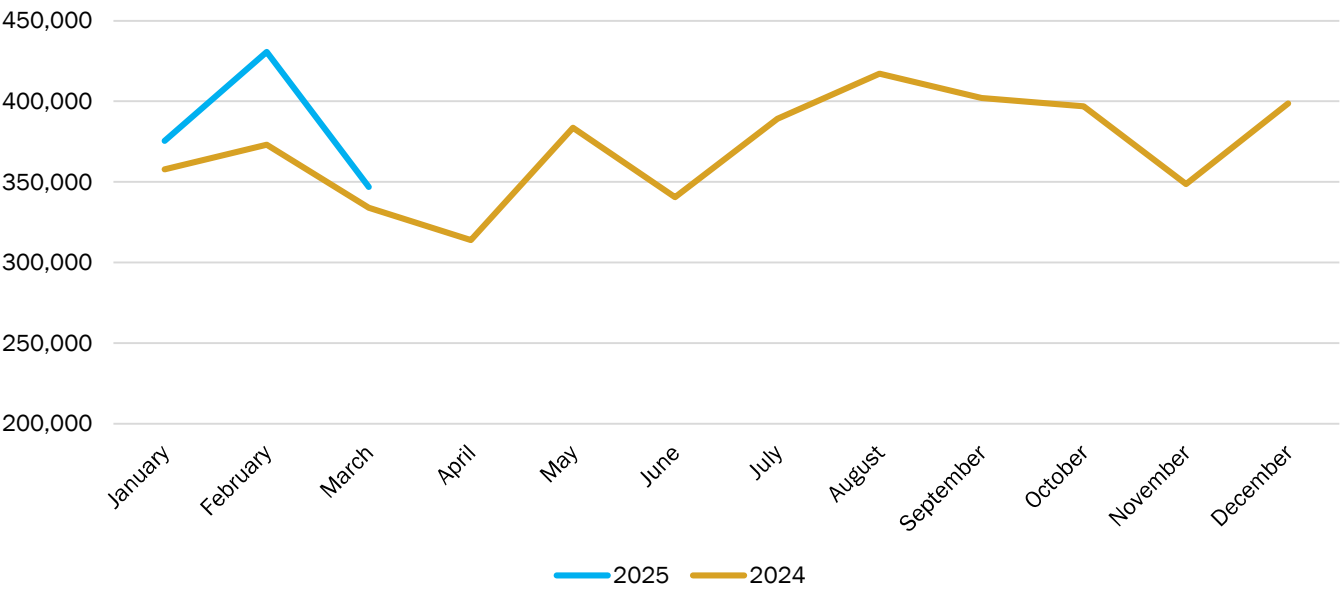

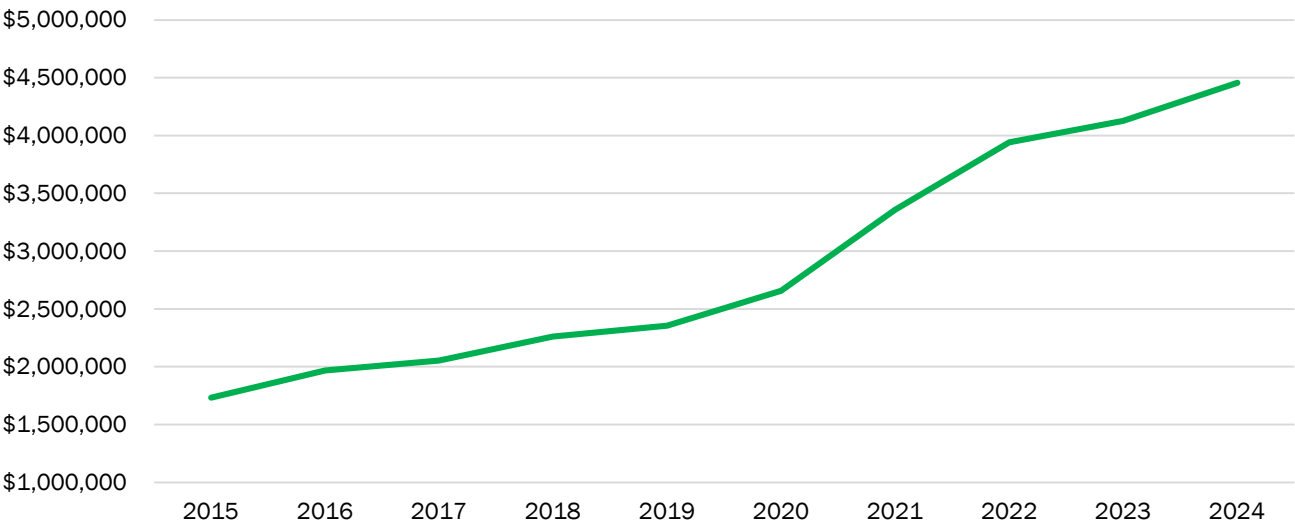

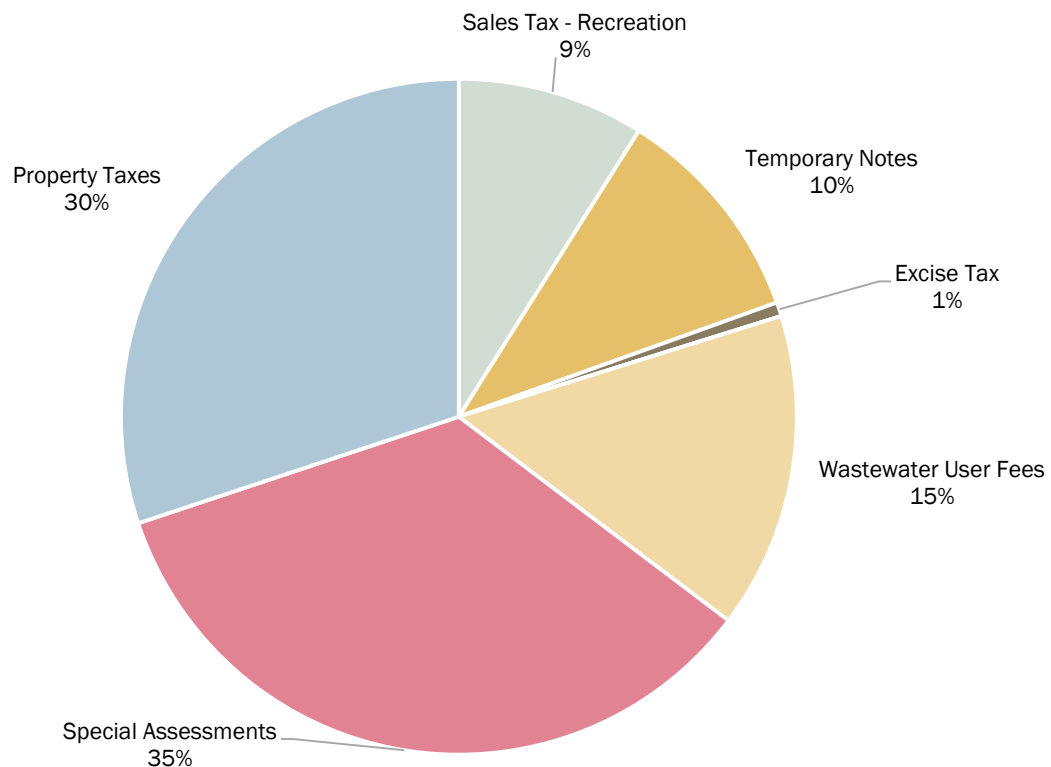

Financing Sources for General Obligation Debt



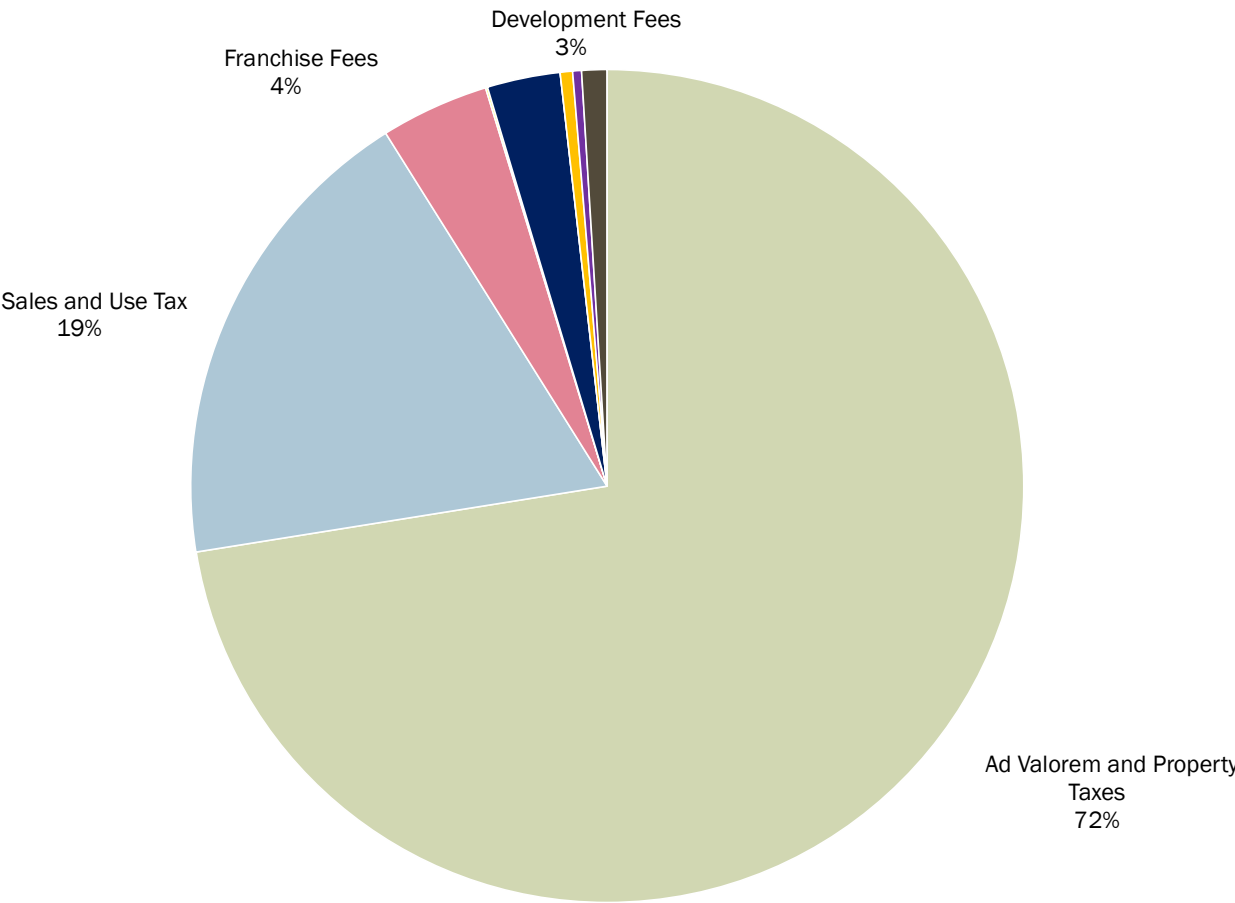

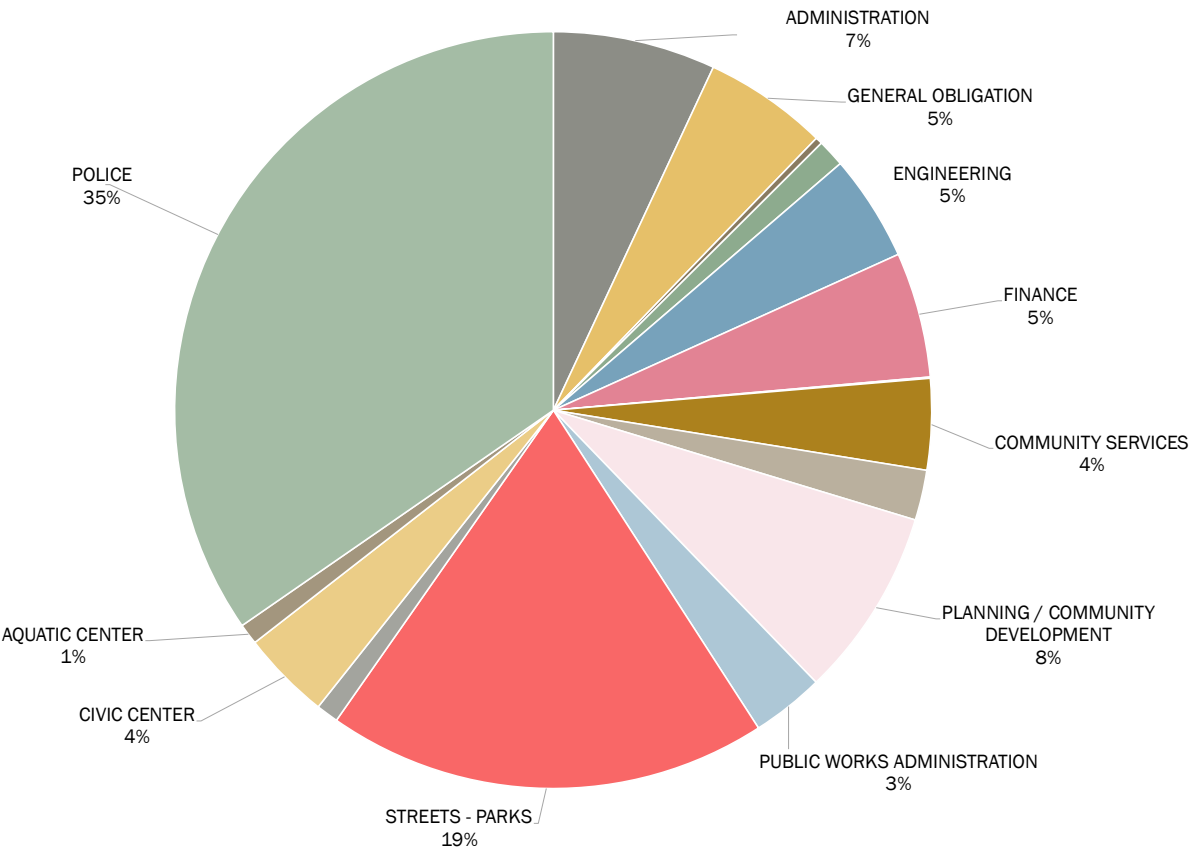
